



## **Saffron Valley Collegiate COVID-19 Return Home School Agreement**

### **The school will:**

- Provide an environment which has been risk assessed in response to the COVID-19 infection
- Adhere to the social distancing rules as set out by the government as much as we reasonably can
- Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs
- Contact parents/carers if your child displays symptoms of COVID-19
- Inform you if staff or children in your child's 'bubble' show symptoms of COVID-19 as this will mean you will all need to self-isolate for at least 14 days or until the test comes back negative
- Continue our clear and consistent approach to rewards and sanctions for children as set out on the Behaviour Policy as well the expectations outlined in this agreement
- Communicate between home and school through notices, newsletters, text, email and the school website.

**As a parent/s, I/we will help my child at school, I know and understand that:**

- I have read the returning to school document and understand the expectations of my child and I upon returning
- If my child, or anyone in my household, shows symptoms of COVID-19, I will not send them to school, we will self-isolate for 14 days as a family, I will get them tested and I will let the school know as soon as possible via telephone
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately. I understand that will have to self-isolate for 14 days unless they undergo a test which proves negative
- When dropping off and picking up, I will strictly stick to the school timings for my child and adhere to the 2 metre social distancing rules
- My child must not bring any items into school with them or take items home from school apart from water bottles
- I will need to remind my child about social distancing rules but accept that are difficult to follow and that my child may not always do this successfully
- My child will need to use good respiratory and hand hygiene
- I will not be allowed into the school without a pre-arranged appointment – I will make appointments via telephone or email
- I need to support all staff in their efforts to create an 'as safe as possible' environment during this crisis
- Read all letters/messages/emails that are sent home
- I need to inform the school immediately of any changes to parents/carers and emergency contacts details
- If my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe. It may be appropriate to complete an individual risk assessment

**I will do my best to:**

- Adhere to the social distancing rules in class and around the school
- Tell an adult if I feel unwell
- Not bring things into school from home, or take things home from school with the exception of my water bottle and packed lunch
- Only use the equipment provided to me by school and no other
- Not mix with any other children in school who are outside my 'bubble'
- Only enter and exit the school building from my designated area
- Follow good respiratory hygiene: coughing and sneezing into elbow or tissue (catch it-bin it-kill it)
- Follow good hand hygiene – use soap and water for 20 seconds/ hand sanitiser
- Behave well at all times to maintain the safety of myself and others, making sure that I make choices that are Ready-Respectful-Safe
- Follow these expectations and know that if I don't, I will be sent home and will not be able to come back into school until I can be safe
